Report on Workshop conducted by IQAC

Title: One day Workshop on "Intellectual Property Rights (IPR)"

Date: 23rd April 2019

Preamble:

A One day workshop on Intellectual Property Rights has been conducted on 23rd April 2019, at Shri. Shivaji Education Society, Amravati's Shri. R. R. Lahoti Science College, Morshi in order to spread the knowledge about Intellectual Property Rights among the Intellectual class of Professors, Researchers and students to know the importance and process of filing IPR. This workshop has been organized collaboratively with the Shri. Shivaji Education Society's Mahatma Fule Mahavidyalaya, Warud, Art's and Commerce College, Jarud, YDVD College, Tiwasa and Bhartiya College, Morshi, Dr. Shyamaprasad Mukharji College, Shendurjanaghat affiliated to SGB Amravati University, Amravati.

A total of 90 delegates from different colleges were participated.

Description about the Program:

On the Inaugural function, Dr. N. N. Saste, Ex. Principal of Shri. Shivaji Education Society Amravati's Science College, Nagpur participated as Chief Guest and Key note speaker. In his Chief guest address, he emphasized on the new process of NAAC Reaccreditation and importance of IPR and he advised researchers to file the patents before publishing their innovative ideas in the research papers. He also asked to come forward to register their difficulties in sustaining their rights. Dr. G. R. Tadas, Principal of Shri. R. R. Lahoti Science College, Morshi presided over the function guided the delegates in his presidential speech. Dr. J. D. Wadate, Principal Mahatma Fule Mahavidyalaya, Warud; Dr. Dr. N. J. Meshram, Principal of YDVD College, Tiwasa; Dr. Suresh Bijwe, Principal of Bhartiya Mahavidyalaya, Morshi; Dr. Ramdas Fulari, Principal, Dr. Shyamaprasad College, Shendurjanaghat were Guest of Honour for the Inaugural Function.

The inaugural session was ended at 11.45 am. After a short tea break, the first Technical session was started at 11 am. This session included the Scholarly and interesting talk by Dr. Mangala Hirwade, Head, Central Library, RTM Nagpur University, Nagpur on "IPR - Tool to protect Inventions and Creations". Her lecture started with the topic, 'What is Intellectual Property'. Then she discussed on different aspects of Intellectual Properties like What is a Patent, Patent Rights, Trademarks, Industrial Design, Geographical Indication, IC Layout (Semiconductor, Trade Secret, Copyright, Protection of plant varieties, Farmers' Rights and

Researchers' Rights. She concluded the talk by explaining the rationale of protection and the nature of IPR. IPR are monopoly rights. She emphasized that IPR have to be renewed from time to time for keeping them enforced except in case of copyright and trade secrets.

Technical Session – II: was started at 12.45 pm by the talk of Dr. Sandip A. Waghule, PGTD Physics of SGB Amravati University, Amravati, he begins with the History of Intellectual Property from beginning to evolving phase. Subsequently explaining the formation of World Intellectual Property Organization and its roles and functions i.e., IPR agreement administration, IPR Practices harmonization. Further explaining the Indian scenario of Intellectual property system and the Office of the Controller General of Patents, Designs and Trademarks, Department of Industrial Policy and Promotion. Subsequently explaining the roles and functions of Intellectual property Office in India. There is patent to his credit so he had shared all his experience with the delegates and appeal the researchers for patenting their research. Session ended at 1:45 pm.

All the delegates were invited for the lunch from 1:45 to 2:15 pm.

In the post lunch technical session – III Adv. S. D. Hande, LL.M in IPR enlightened the audience on the history of Intellectual Property Rights & said that protection of IPR (intangible property) has definite benefits, such as to propagate innovative culture, profitability, market leadership and helps creation of wealth for the individual and Nation. He stressed on the importance of IPR and need for its protection. He also described about whom & how to apply for copyright and Online Copyright Registration process. He ended his session with important information for the filing of patent.

In the technical session-IV Dr. Mangala Hirwade and Adv. S. D. Hande after explaining the process of filing the Patent application, Copyright application, Trademark application, Design application and the Scheme for Facilitating Start-ups Intellectual Property Protection. The discussion session has more interactions from Researchers and students and this workshop kindle the younger minds present for in the workshop. The entire session was an interactive session and the speakers answered many queries raised by the participants.


The workshop ended with the valedictory function and distribution of certificates at 5:30 pm.
