The OBC Cell is headed by the Principal, of our College. The college has also appointed Nodal Officers to oversee the effective implementation of reservation policies/rules related to Other Backward Class as per Government of India/UGC notifications.

Objectives

Ensure reservation norms in the admission of students and in the appointments of teaching and non-teaching staff.

- Maintain social relationship among the admitted students in the college and resolve issues, grievances, representations etc.,

- Explore redressal mechanisms and provisions for remedial coaching, counselling etc.,
- Coordination of equal opportunity, welfare and other schemes including financial assistances from the government and UGC.

The overall functions of OBC Cell at our College are the following:

- I. Informal Advisory Committee on OBCs
- II. Ensuring Reservation policies in regard to OBCs
- III. Complaint Register for OBCs
- IV. Maintenance of Reservation Rosters/Registers
- V. To ensure compliance of the orders of reservation issued and other benefits admissible from time to time in favour of OBCs
- VI. To ensure provisions for an environment where all such students feel safe and secure.
- VII. To provide prompt counselling for any emotional emergencies arising on account of any events at the campus.
- VIII. To communicate with the UGC/MHRD/ etc. with respect to supply of required information, answering queries and clearing doubts with respect to reservations data/information etc.
- IX. To arrange for special opportunities to enhance the career growth of OBC students.
- X. To circulate State Government and UGC's decisions about different scholarship programs.
- XI. To communicate with Office of the Commissioner for OBCs in response of representations/ complaints.
